### Deliverable 6.3.1 Network of organizations involved in PHC

Organization of the SECOND 1-day public consultation at Ardino aiming to the establishment of an informal network composed by the competent stakeholders for the development of a citizens' oriented PHC Governance Plan

### 1. Summary of the consultation

The second open one-day public consultation took place on 16<sup>th</sup> of October, 201916 in the hall of the "Rhodopska Iskra - 1921" Community Center in the town of Ardino and was combined with the "Open Day" organized by the hospital, where anyone interested could see the renovated and re-equipped hospital, as well as benefit from a free examination by specialists from various specialties.

The event took place according to a agenda, including the following main topics:

- Introductory speech and presentation of the project
- Primary medical care status and prospects in Bulgaria
- Ways to improve primary care
- Conclusion and discussion



In order to ensure no less than 40 participants in the event, invitations were sent to all parties interested in the topic - competent local stakeholders for the creation of a citizen-oriented Primary Care Management Plan , incl. representatives of local government and educational institutions from the district. In this way, 23 participants took part in the consultation, according

to the attendance list attached to this report.

Each of the participants was given informational materials on the paper folder project, the program of the public consultation; block-sheet format A 4; pen. To ensure the visualization of the event, 2 roll-up banners with a stand were used, developed within the project and provided by the Contracting Authority.

#### 2. Objectives of the public consultation

The main objectives of the public consultation were the following:

- To present to the general public the project in which "Multi-profile Hospital for Active Treatment - Ardino" EOOD is a partner and, accordingly, the activities related to it
- To create the preconditions for the creation of an informal network composed of competent local stakeholders for the creation of a citizen-oriented Primary Care Management Plan.

# 4. Program of the public consultation - a brief presentation of the topics and subtopics

The program and topics of the public consultation were provided by the Aristotle University of Thessaloniki - Department of Medicine (Partner N2) and accordingly included:

### • Opening statement

Dr. Güner Osman, Director of "Multi-profile Hospital for Active Treatment - Ardino " EOOD - the city of Ardino, greeted the participants in the public consultation and presented the project "Strengthening primary Medical care in Isolated and deprived cross-border arEas (Smile)".

### • Primary medical care - status and prospects in Bulgaria

Evgeny Ivanov, General Manager, "Euroconsultants Bulgaria S.A." AD, a consultant on projects in the field of health care examined the current state of primary medical care in the country, the main problems and at the same time the prospects for its development.

## **Topics and subtopics**

### • Ways to improve primary care

Rumyana Draganova, a consultant on projects in the field of health care, presented various opportunities for improving primary medical care in our country, including its adequate financing through various options for financing activities in health care.

# • Discussion on opportunities to improve the provision of primary care with a focus on providing an accessible environment for people with various disabilities




# General assessment of the level of organization and conduct of the public consultation agenda


# • General assessment of the level of organization and conduct of the public consultation - methods and techniques for presenting information


# • General assessment of the level of organization and conduct of the public consultation - working materials

# • General assessment of the level of organization and conduct of the public consultation - technical base (hall and equipment)



• General assessment of the lecturers' qualifications, experience and way of presenting information - qualifications and experience on the topics of the public consultation




• General assessment of the qualifications, experience and way of presenting the information by the lecturers - behavior during the public consultation

where: 5 - excellent; 4 - very good; 3 - good; 2 - medium; 1 - weak




• Did the participation in the public consultation contribute to increasing your knowledge regarding the management of primary care




## • Are you satisfied with your participation in the public consultation?

## 6. Comments and conclusions

The issue of improving the provision of primary medical care in the cross-border region is extremely pressing. On the Bulgarian side, there are problems in the organization and coordination of the individual units, which often cause serious delays in the provision of medical assistance. The remoteness of some settlements in combination with the mountainous terrain makes it even more difficult to reach some patients, who at the same time are physically much closer to a medical facility in Greece than in Bulgaria.

Such kind of problems can be solved by creating a Primary Care Management Plan, and the first steps for its creation were initiated in the framework of the discussion among the participants of the consultation. The representatives of competent local stakeholders for the creation of a citizen-oriented Primary Care Management Plan, incl. representatives of the local government and educational institutions from the area, who took part in the public consultation, discussed the steps to create and implement such a plan, the responsible parties and other aspects.

As a result of the event and the opinions shared by the participants during the discussions, as well as through the questionnaires filled in by them, the following conclusions can be drawn:

• The overwhelming number of participants in the consultation rated its level of organization and implementation (agenda, methods and techniques for providing the information, working materials and technical base) as very good or excellent

- The overall assessment of the lecturers' qualifications, experience and behavior was highly rated excellent and very good, respectively
- More than 82% of participants declared that their participation in the public consultation contributed to increasing their knowledge regarding primary care management; for the rest of the participants it was partial, which is explained by the fact that the public consultation was attended by many professionals in the field of health care, for whom the topic is largely familiar
- 95% of the participants are completely satisfied with their participation in the public consultation, and the rest share that they are "partially satisfied"
- In conclusion, 100% of the participants shared that their initial expectations regarding the public consultation were fully justified.
